- Ambassador, chargé d'affaires, extraordinary and plenipotentiary envoy, or senior officer of the armed forces;

- Member of the management or supervisory body of a state-owned enterprise (including municipal enterprise);
- Head of an international intergovernmental organisation, deputy head or member of its management or supervisory body;

- Head of political party, his/her deputy, member of the management body;

- Parents, brothers, sisters, grandparents, grandchildren.
